Meriplex Communications, Ltd.'s (Meriplex) respects your privacy and is committed to maintaining the privacy and confidentiality of personal data we collect. The purpose of our Privacy Statement is to demonstrate our firm commitment to the privacy and protection of all persons who provide personal data to Meriplex and its affiliates. This Privacy Statement describes the ways we collect information from and about you, and what we do with the information, so that you may decide whether or not to provide information to us.

1. Data Collection

The information we collect may include your personal information, such as your name, contact information, financial account numbers, product and service selections and orders or other things that identify you individually.

Generally, we may collect information about you in the following manners: you may provide your personal information to us via email or other written correspondence, telephone calls, or other means via third party providers.

We will not intentionally collect or maintain, and do not want you to provide, any information regarding your medical or health condition, race or ethnic origin, political opinions, religious or philosophical beliefs or other sensitive information.

2. Information Use

We may use your information to process your service requests, handle orders, deliver products and services, process payments, communicate with you about orders, provide access to secure areas of the Website, recommend products and services that might be of interest to you, and to enable us to review develop and continually improve the products services and offers we provide. We also use this information to prevent or detect fraud or abuses of our Website and to enable third parties to carry out technical, logistical or other functions on our behalf.

3. Disclosure of Personal Information

We do not sell or disseminate personally identifiable information to third parties without your consent.

Unless we have your permission or are required by law, we only share your personally identifiable information with our affiliated group companies in order to provide the services. We make every reasonable effort to ensure that such our affiliates process your personally identifiable information in accordance with the terms of this Privacy Policy.

We may share non-personal, non-individual information in aggregate form with other companies within our affiliates. All such other companies within our affiliates must commit to complying with out instructions and to keep all personally identifiable information secure. Notwithstanding other provisions of this Privacy Policy, we may disclose personally identifiable information and account information in special cases when it is necessary to identify, contact, or bring legal action against someone who may be violating any user agreement or may be causing injury to or interference with us, you, or anyone else that could be harmed by such activities. We may also disclose personally identifiable information as necessary to collect for the charges related to the services we provide.

We reserve the right to disclose your personally identifiable information as explicitly set forth in this Privacy Policy or any user agreement agreed to by you, or as otherwise required by government or law enforcement officials. We can, and you hereby authorize us to, disclose any information to law enforcement or other parties that we in our sole discretion, believe is required or appropriate to comply with the law.

4. Opting out of communications

Meriplex gives you an opportunity to chose to opt-out of personal data being disclosed to third parties for a purpose incompatible with the purpose for which it was originally collected (except for meeting applicable legal requirements or permitting third party service providers who perform functions on our behalf as described in section 3 of this Privacy Statement), including your opting out of receiving future marketing mailings.
